

## COOKIES POLICY

### A. Introduction

Goldenburg Group Ltd (hereafter 'The Company') websites uses cookies for its proper operation as well as the best experience of its visitors.

### B. What are Cookies?

Cookies are small text files containing a string of characters that can be placed on your computer or device that uniquely identify your browser and / or device. The information used by browsers (Chrome, Mozilla Firefox, etc.) can help to improve the functioning of the Website enabling it to recognize the user's preferences each time the user returns.

Other technologies, including the data we store on your browser or device, the information associated with your device, and other software, are used for similar purposes.

The Company's website does not request personal information from its visitors while navigating its content. The Company's website may collect personal information of its visitors / users. Personal information is the data that can be used to identify or communicate with an individual, as well as other information relating to that person. Therefore, the information we collect from you or about you differs depending on the service you choose to use through our Website.

### C. Cookies Types

There are generally four categories of cookies, "visit cookies", "permanent cookies", "first party cookies", and "third-party" cookies. The Company usually uses one category of cookies - "visit cookies".

- Visit cookies

These are temporary cookies that remain in the cookie file of your device's browser only during your visit and are deleted when you close the browser.

- Permanent cookies (persistent cookies)

Those cookies remain on your browser even after the browser closes, sometimes for one year or more (the exact length of stay depends on the lifetime of each cookie). Permanent cookies are used when the site administrator may need to know who you are for more than one visit (e.g., remembering your username or your site configuration preferences).

- **First-party cookies**

These are cookies installed on the browser and / or hard drive of your device from the site you are visiting. This includes assigning a unique identifier to you to monitor your site navigation. Website administrators often use first-party cookies to manage visits and for identification purposes.

- **Third-party cookies**

These are cookies used by third parties, such as social networks to track your visits to the various sites they advertise. The site administrator has no control over these third-party cookies.

#### **D. How long will the cookies stay on my device?**

For how long a cookie will remain on your computer or on a mobile device depends on whether it is a persistent cookie or a session cookie. Session cookies will remain on your device only until you stop browsing. Permanent cookies remain on your computer or mobile device until they expire or are deleted.

#### **E. Services and Third-Party Tools**

Service providers may use cookies and these cookies may be stored on your computer when you visit our site.

The company uses Google Analytics to analyze the use of our site. Google Analytics collects information about the use of the site through cookies. The information collected about our site is used to generate reports about the use of our site. Google's privacy policy is available at <https://www.google.com/policies/privacy/>.

We use Facebook Business to analyze usage of our site and provide better user experience. This service uses cookies in order to enable us to advertise our product better and analyze website traffic. #### **F. Collection of Information**

The information that we collect is used to improve the quality of our services, to prevent the abuse or misuse of our services, comply with legal obligations and to make our marketing more efficient. The company collects your IP Address upon accessing client's area and/or trading platform and is in conjunction with the acceptance of the client account opening documentation, in order to improve identification and security.

### **H. How do I manage or delete information about me?**

The data is stored for as long as necessary to provide services to you and other users, including those described above. The information related to you will remain stored until you leave our website.

### **I. Manage Cookies**

The installation of "cookies" is only allowed with the consent of the visitor / user and after appropriate updating.

The user can modify the browser settings to block some or all the cookies. Most browsers allow you to deny cookies and delete cookies.
